MEMORANDUM OF UNDERSTANDING (MOU) between

Milestone charitable trust

and

NMKRV College for Women

I. PURPOSE & SCOPE

This Memorandum of Understanding (the "MOU") is made and entered on 21 of January, 2019 (the "Effective Date") by and between:

NMKRV College for Women, with its principal place of business located at 3rd Block, Jayanagar, and Bengaluru - 560011, (hereinafter referred to as "the College")

And

Milestone Charitable trust, with its principal place of business located at, 1st Floor, #787th cross Triveni road, Yeshwanthpura, Bengaluru- 560054, (hereinafter referred to as "the Coaching institute").

Hereinafter the College and the Coaching institute shall individually be referred to as a "Party" and collectively as "the Parties".

RECITALS:

A WHEREAS, the College is in the field of providing higher secondary, degree and postgraduate education;

B WHEREAS, the Coaching institute has expertise in the area of providing Competitive examinations coaching;

C WHEREAS, the College desires to engage the Coaching institute to provide Banking examination coaching to its students in the area of Coaching institute's expertise and the Coaching institute is willing to provide such services to the College;

NOW, THEREFORE, the Parties hereby agree as follows:

The purpose of this MOU is to clearly identify the roles and responsibilities of each party as they relate to in particular, *providing Banking entrance examinations coaching to the students of the college*



2. *Using the premises and the facilities of the college to provide the coaching.*

II. RESPONSIBILITIES OF THE COACHING INSTITUTE UNDER THIS MOU

The Coaching institute shall undertake the following activities:

1. Provide quality Banking examination coaching to the students of the college. (Program detail as per Annexure 1).
2. Commit to complete the entire syllabus as agreed upon for the batch by 2nd week of April 2019.
3. Update the records maintained at the college regarding coverage of the syllabus for every training session conducted.

III. RESPONSIBILITIES OF THE COLLEGE UNDER THIS MOU

The College shall undertake the following activities:

1. Provide infrastructure support to the training institute to deliver the coaching.
2. Take the responsibility of admission process and collection of the course fee.
3. Maintain a proper database of the students enrolled for the above mentioned course, and such database shall be made available for the COACHING INSTITUTE when requested by the latter.
4. Maintain the classroom decorum and provide proper environment to conduct training sessions
5. Commit to get minimum registration of 50 students for the said course.

IV. IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:

1. The MOU may be modified from time to time by mutual agreement of the Parties.
2. The MOU may be terminated by mutual agreement or by either of the parties by providing a written notice within 1 month of the completion of the on-going programs. However, termination of the MOU will not, in any manner, impact the responsibilities of both the parties towards the conduct of the courses already in progress at the time of termination notice and such a notice will come into effect only after culmination of such program (s).

During the tenure of the MOU, the parties will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance with this MOU.



V. FUNDING and FEES

The Parties to the contract have mutually agreed for a remuneration of Rs.1,700/- (Rupees One Thousand Seven Hundreds only) as course fee for each admission of the student to the course:

- The COLLEGE shall pay the INSTITUTE 50% from the sum of course fee which is collected from the students who join the course, after the completion of 50% of the course within a period of a week's time, as the same is required to arrange Faculties resources, Material, etc for the smooth conduct of the course and .
- The COLLEGE shall pay the balance 50% to the INSTITUTE after the completion of the syllabus of the said course within a period of a week's time, which shall be intimated to the College in writing or e-mail.
- The above mentioned remuneration is inclusive of all applicable taxes.
- The cost of providing any extra or associated service will be charged directly to the students.

VI. RESOLUTION OF DISPUTES

The Parties hereby agree that any disputes arising out of or in connection with this MOU shall be handled within the jurisdiction of the courts of Bengaluru.

VII. EFFECTIVE DATE AND SIGNATURE

This MOU shall be effective upon the signatures of the authorized officials of the Parties. It shall be in force from _____ to _____.

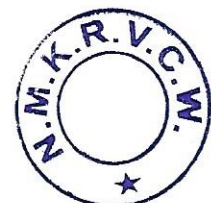

NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. Objective:

The objective of this MOU is to enable students of "NMKRV College for Women" and its affiliated college access to resources that would enhance their employability.

2. Period of MOU:

This MOU shall come into force and effect from the date of execution and shall remain valid for a period of **Two years** from such date after which the same may be reviewed by either party. However, if the same is not renewed this arrangement will be deemed terminated on the expiry of the said duration period.

3. Roles & Responsibilities of the College/University:

- a. The College/University shall be responsible to nominate one person with adequate accountability and responsibility to coordinate the engagement. The person so appointed would act as the single point of contact (SPOC) for the proposed initiative.
- b. The College/University shall share in their letterhead the details of the students who will attend the aforesaid training program with GTTF like name, email ID, contact details, Name of the Company in which Candidate is placed (current Company), qualification (along with the year of completion/pursuing) and other documents as per GTTF training requirements..

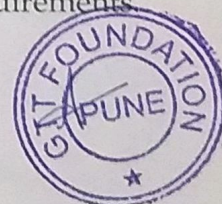

- c. It would be the responsibility of the College/University to ensure that proper publicity of the Program is made through College/University website.
- d. To encourage the Students to register for the Program by informing them about the benefits of the program.
- e. "NMKRV College for Women" to refrain conducting any of their training or call with the students when GTTF training is going on.
- f. It would be their responsibility to ensure that all their students adhere to training schedule.
- g. To provide all the support services and facilities to **GTTF** during the conduct of the said Training Program.
- h. To coordinate with GTTF and facilitate conduct of all the assessments including the assessment to be conducted by the external agency (if any) identified by GTTF, as per schedule communicated by GTTF.
- i. **To provide the placement details of the students who have undergone the aforesaid training.**

4. Roles & Responsibilities of GTTF:

- a. GTTF shall be responsible to provide access to employability enhancement related activities through blended learning model.
- b. GTTF will arrange for assessment of its own and also arrange external assessment as required.
- c. GTTF will facilitate placement of students with their client/ customer companies in suitable positions and also recruit for their own requirements

5. Other Terms & Conditions:

Following are the other terms and conditions of MOU:

- a. The students enrolled should complete the training as scheduled.
- b. The students should register as per the process of GTTF and appear for Assessments as required.
- c. Program Coordinator to be appointed by college/University
- d. TPO's active support and participation is required for smooth & efficient conduct of the program.
- e. The College/University shall not write/publish any material or use any logos/names of GTTF/ in any of the publications without prior written consent and approval from GTTF.

6. Commercials:

This skills enhancement **training program** is free of cost. GTTF shall not charge any fees on whatsoever account/name from the students or the College/University for conducting the aforesaid training program.

7. Certification:

Certificates shall be awarded by GTTF to the students on successful completion of the training and clearing of the assessment held post completion of the training program.

Both parties agree that it would be their endeavor to prevent any liability arising out of default or non-compliance of the MOU terms by the other party.

9. Termination:

- a. Both parties can terminate the MOU with a prior written thirty (30) day notice on default of terms or non-adherence to any condition or responsibilities by the other party as outlined in this MOU in case such default is not rectified within such 30 days.
- b. Both parties also agree that it would be their professional endeavour that despite any termination of the MOU, progress would continue, without any prejudice to the ongoing Training Programs, which would be without any hindrance and would be progressed for completion.

10. Entirety & Amendment:

This MOU contains the entire understanding between the Parties in relation to the Training Program. If during the operation of the MOU, circumstances may rise which call for alteration / modification to this MOU, such alteration / modification shall be mutually discussed and agreed upon in writing. Such changes will be formalized in writing as an 'Addendum' to this MOU. Any changes/amendments to this MOU not in conformance to this section shall be deemed to be void-ab-initio.

- Already in its possession other than as a result of a breach of this clause; or in the hands of the public other than as a result of a breach of this clause.
- In the event of any of the parties becoming legally compelled to disclose any confidential information, such party shall give sufficient notice to the other party so atoneable the other party to seek a timely protective order or any other appropriate relief. If such an order or other relief cannot be obtained, the party being required to make such a disclosure shall make the disclosure of the Confidential Information only to the extent that is legally required of it and no further.

d. Both parties agree not to deal directly or enter into any business agreement with any of the partners or associates or customers of either party during the term of the agreement and also after the agreement have been terminated, not earlier than two years from the date of termination.

13. Force Mature:

- a. Neither party to this MOU shall be liable for any failure or delay on its part in performing any of its obligations under this MOU, if such failure or delay shall be result of or arising out of Force Mature conditions and, provided that the party claiming Force Mature shall use its best efforts to avoid or remove such cause of non-performance and shall fulfil and continue performance hereunder with the utmost dispatch whenever and to the extent such cause or causes are removed.
- b. Any extraordinary event, which cannot be controlled by the parties, shall for the purpose of this MOU be considered as a Force Mature event. Such events include acts of God, acts or omissions of any Government or agency thereof, compliance with rules, regulations or order of any Government Authority. Provided however, if either party claims that existence of any of the aforesaid conditions is delaying or disabling the performance by said party of its obligations under this MOU, such party shall give immediate notice to the other party of the existence of such conditions whose existence are claimed to delay or disable the performance of obligations as aforesaid.

15. Jurisdiction and Arbitration:

- In the event of any dispute or difference between the Parties hereto, the courts in Pune alone shall have exclusive jurisdiction to try any matter arising between the Parties here-to and accordingly both the Parties shall submit to the exclusive jurisdiction of courts in Pune, Maharashtra.
- Any dispute arising out of, in relation to or in respect to this MOU shall be settled through mutual consultation and agreement, by the Parties to this MOU. In case a settlement is not arrived at within fifteen (15) days of reference, the dispute/s shall be referred to a sole arbitrator to be appointed in accordance to the Arbitration and Conciliation Act, 1996 as amended from time to time. The place of arbitration shall be Pune, India.
